Terms & Conditions

REFUND POLICY AND GUIDELINES:

NYLC Housing: The Housing Placement Fee (\$200) is nonrefundable. All applicants are required to pay a minimum of \$1,600 (or \$1,400 for double room bookings), which includes the Housing Placement Fee + \$1,400 Down payment towards the first month's rent, when submitting the application. This \$1,400 down payment is considered a pre-payment to the final housing balance. If submitting this housing application less than 4 weeks prior to arrival, the total invoiced housing cost and the (optional) airport pick-up fee must be paid in full for NYLC to make the housing booking. Cancellations prior to arrival will be accepted and the housing payment (less the Housing Placement Fee) will be refunded when made at least 2 weeks prior to arrival. If cancellation is made less than 2 weeks before arrival, the \$1,400.00 for 4 weeks will be charged. In the event that the guest can provide documentary evidence of an F1 student visa denial, the deposit may be refundable with written notice of the visa denial if done within a reasonable time frame determined by the Housing Coordinator. If cancellation is made after arrival, 2 weeks of notice is required and the accommodation fee (rent) must be paid during the 2 weeks of stay.

Other terms and conditions may apply for out of network properties such as Studio 99; Park West Hotel; The Royal Park Hotel; and Broadway Hotel and Hostel, where the penalty may exceed \$400. Individual terms and conditions may be reviewed upon booking.

Airport Transfers: The driver uses the provided flight information to track that a flight arrives on schedule. The

driver will wait for a student up to 2 hours after the flight is scheduled to arrive. The driver reserves the right to charge \$60 per hour for any additional waiting time. Should the student miss their flight or connecting flight for any reason, the student must notify the school and/or driver as soon as possible. Not doing so will result in the transfer not being completed and full loss of the Airport Transfer fee.

AGREEMENT: I am at least 18 years old. By signing this form, I realize that I agree to these terms. I have read and completed this application for housing. I understand the cancellation/refund policy. I agree to abide by the guest regulations of the residence/hotel/hostel. I understand that availability is not guaranteed.
